We recommend that our students pay attention to the following points in order to be able to register in the I. Semester of 2022-2023 without any problems.

- If you are going to be in the 2nd semester for the master's program or in the 3rd semester of the doctoral program as of I. semester of 2022-2023, you must have completed your advisor assignment process in the program no. 71 at https://oibs2.metu.edu.tr/Menu_Program_0/. Otherwise, the SYSTEM WILL NOT ALLOW YOU TO REGISTER. It is enough to do this process once in your program.
- During the interactive registration, you must register for the course and have the approval of your advisor.
- If you do not get your advisor's approval, your registration will be considered incomplete, and the SYSTEM WILL NOT ALLOW YOU TO REGISTER DURING THE ADD-DROP PERIOD. You will not be allowed to register in any other way.
- During the add-drop period, only students who have graduated from master's degree are allowed to register for doctorate. If you have not registered in the interactive registrations, registration will not be possible during this period. You will not be allowed to register in any other way.
- In order to substitute the taken courses in "NI" status in the Scientific Preparation program to your main program, you must apply until the add-drops period in the first semester you started the program (with the replacement disposition application/request and the course replacement (substitution) disposition form at http://iam.metu.edu.tr/en/forms).
- Students in MSc with thesis program can take the course IAM 590 "Graduate Seminar" starting from their 3rd semester.
- Students in PhD program can take the course IAM 690 "Graduate Seminar for Ph.D. Students" starting from their 3rd semester.
- After the advisor assignment in the program no. 71, during each registration students enrolled in MSc with thesis and PhD program must take both of the thesis advisor's courses with course codes 800/900 and 500/600 (500 and 800 for master's degree, 600 and 900 for doctorate).
- In accordance with the graduate regulations, it is compulsory for all students who start the MSc program with or without thesis and PhD program to take the course 9700698 "Research Methods and Ethics" in "MUST" status.
 Students who have been adjusted within the scope of amnesty are required to take this course if they have not been taken before.
- Those who want to apply to the transfer from the non-thesis program to the thesis program must submit their official applications using their METU e-mail addresses by the evening of Friday, September 30, 2022, AT THE LATEST, according to the information on our website (<u>http://iam.metu.edu.tr/transferring-non-thesis-option-thesis-option-within-program</u>). IF THEIR APPLICATIONS ARE ACCEPTED after the evaluation, THESE STUDENTS MUST REGISTER FOR COURSES 500/600 AND 800/900 DURING THE ADD-DROP PERIOD.
